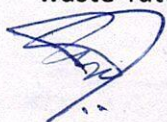
And

IIHMR University, Jaipur (IIHMR University) having it's registered office at 1, Prabhu Dayal Marg, Near Sanganer Airport, Jaipur - 302029 through its authorized signatory Dr. Shusheela Sharma (hereinafter referred to as the "**SECOND PARTY**", which expression shall, wherever the context so requires or admits, mean and include, his heirs, executors)

Both **OSG** and **IIHMR University** are individually referred to as 'Party' and collectively as 'Parties'

WHEREAS:

- OSG is a social initiative that targets waste management, recycling and treeplantations in the heart of India's densely populated & polluted area. OSG strives towards a zero-waste future and creates employment for rag pickers to move to the formal sector.

ensuring they work safely with dignity and gain financial literacy. It's main goals are; to help change behaviour by educating people on the harm that irresponsible disposal of waste causes, ensuring households/corporates/institutes/schools start segregating their waste at source and offering a pickup of their dry waste, recycling different waste streams collected through certified recyclers, motivating children, households and institutions to join the movement and planting mini forests in the city along with the community. OSG have also won the prestigious International Children's Peace Prize 2021, The Hague, Netherlands.

- B. IIHMR University was established and incorporated as a postgraduate research university by the Government of Rajasthan vide the IIHMR University, Jaipur Act, 2014 (Act No. 3, of 2014) in the year 2014. IIHMR University is recognized as a Scientific and Industrial Research Organization by Department of Scientific and Industrial Research, Government of India.
- C. IIHMR University has approached OSG for management of the dry waste generated from its registered office and OSG has also agreed to help IIHMR University in collection, segregation and management of dry waste in the said campus as per the terms and conditions as mutually agreed hereinafter.
- D. In pursuance of the aforesaid, the Parties wish to enter into this MOU to record their mutual understanding for the purpose specified above.

NOW THEREFORE THE PARTIES HERETO AGREE AS UNDER:

1. Scope:

During the period of this MoU OSG shall ensure the following activities:

- i) OSG will be deploying its personnel and a pickup vehicle to pick up all dry waste from registered office & campus of IIHMR University, Jaipur]
- ii) Pick up services will be free of cost. Pick up vehicle to be stationed at the registered office & campus of IIHMR University from 11 am to 2 pm during which dry waste will be picked up.
- iii) IIHMR University shall provide OSG adequate space for storing the collected dry waste within the registered office, where OSG workers will further segregate the same into different categories, will measure the weight of each category of dry waste and a copy of collected waste with weight of respective categories of waste will be given to IIHMR University.
- iv) To ensure the smooth functioning of the waste management project, OSG will deploy one worker, one driver and a supervisor, who will be permanently working for IIHMR University between 9:30 am to 2:30 pm during initial days of operations. OSG will like to have an office to cater to the varying demand of the region on waste collection, assistance on composting and educational seminar in and outside the institution.

2. Responsibility of IIHMR University

- IIHMR University shall provide space to OSG for the purpose of storing the collected dry waste.
- IIHMR University shall provide proper access to the workers, driver and supervisor to carry out their obligation as per the MOU.
- IIHMR University shall further provide all necessary assistance and infrastructure as may be reasonably required for the proper implementation of the waste management project in its registered office.

3. There will be no financial obligations on both parties under this MOU. This MoU is based on a spirit of cooperation and to make the aforementioned registered office of IIHMR University waste free. There shall be no financial consideration or payment involved between the parties for the management of dry waste.
4. The MOU shall be initially valid for 2 years starting from 01st March 2024 to 28th February 2026 and may be terminated by either Party by serving 30 days prior written notice. The MOU will be reviewed and revalidated mutually.
5. Parties will acknowledge the contribution of each other under this MOU on their website as well as on the appropriate place of the IIHMR University. OSG will be allowed to promote the project in local, national, international platforms.
6. This MOU is largely focused with activities related to IIHMR University's registered office situated at Jaipur. However not restricted to other peripheral supporting disciplines when required.
7. Nothing in this MOU shall be construed as creating a partnership, agency, or other legal relationship between the parties. The MOU aims to foster genuine and mutually beneficial collaboration.
8. Either Party hereby release, covenants not to raise any claim, suit, damages against the other Party and release the other Party of and from all liabilities, claims, actions, damages, costs and expenses of any nature arising out of or related to, or in any way connected with this MoU.
9. OSG can assist IIHMR University partially as well as fully to undertake plantation drive in campus as well outside campus. To cover soil sampling, procuring plant sapling of minimum 4 feet height, planting the saplings, fencing and maintenance for five years period.
10. To collect e-waste from the campus, provide the certificate mentioning the quantity of collected e-waste on annual basis.
11. For wet waste to provide assistance in-campus in making of pits and getting wet waste composted in systematic manner.
12. CONFIDENTIALITY OBLIGATIONS: All information exchanged between the Parties under this MOU (except information as is publicly available), shall be considered Confidential Information. For the purpose of this Clause, the Party that discloses Confidential Information to the other Party shall be referred to as the Disclosing Party, and the party that

receives such Confidential Information shall be referred to as the Receiving Party. The Receiving Party shall not disclose such Confidential Information to any third party, without the Disclosing Party's express written consent.

AGREEMENT FOR DISPOSE OFF GENERAL WASTE

This agreement is between IIHMR University 1, Prabhu Dayal Marg, Near Sanganer Airport, Jaipur-302029 represented by Mr. Neeraj Srivastava, Dy. Registrar (Admin & HR) (hereinafter referred to as the "First Party")

AND

M/s Om Prakash Ranva having its office at 118/1, Valmiki Colony, Opp. Sector-1, Malviya Nagar, Jaipur through its Proprietor, Om Prakash Ranva (hereinafter called the "Second Party")

The agreement shall be deemed to have come in to force only for a period of 2 Months with effect from 16 July 2018 to 15 September 2018 to dispose off General Dry, Wet & Canteen waste from IIHMR University 1, Prabhu Dayal Marg, Near Sanganer Airport, Jaipur-302029 and This agreement may extend till 31 March 2019 subject to satisfactory service. The terms & conditions are as follow:-

1. The Second party will pick Wet, Dry & food Waste in Garbage bags daily from IIHMR University. Second party will be responsible for drop the collected garbage at designated place by the Statutory bodies (Local Bodies / Govt. of Rajasthan).
2. The Second party will pick Garbage at 9 am to 10 am and if vehicle got breakdown than 5 pm on Same day.
3. The Second party will collect the Garbage in Garbage bags at a designated space and First Party will pick the Garbage from same place at IIHMR University campus.
4. The First Party shall pay Rs.14000/- (Rupees Fourteen Thousand Only) per month inclusive all taxes.
5. TDS will be applicable as per prevailing law.
6. The Second party's Staff shall be in discipline while picking the Garbage from IIHMR University Campus.
7. The First party will release the payment in 15 days after receiving of the bill with complete supporting recd.
8. The Second party shall make sure that none of its staff will not find in drunken state during the picking of Garbage at IIHMR University.
9. If the second party will unable to give satisfactory services after Extension of this agreement, The First party reserves the right to terminate this agreement immediate effect without giving one month notice or not to accept this Agreement.
10. In case of any dispute, the same will be subjected to Jaipur Jurisdiction only.
11. If all above terms & conditions are acceptable to you than sign the duplicate copy of this agreement as a token of acceptance.

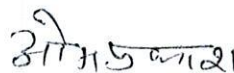
