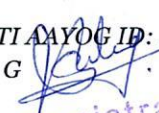

1. The duration of the CMSDF is 2 years effective from the date of joining. During this period fellows will receive a monthly stipend of Rs.60,000/- (TDS as applicable).
2. The program shall commence from **9th July 2024 at Bhubaneswar**. Necessary arrangements to be made to get relieved from the current engagements or jobs to positively join on the given date.
