

Memorandum of Understanding
between
International Institute of Health Management
Research (IIHMR) Delhi
and
IIHMR University, Jaipur

Preamble:

The International Institute of Health Management Research (IIHMR) Delhi, was established in 2008 under the Society for Indian Institute of Health Management Research, 1984 and is registered under the Societies Registration Act, 1958, having its campus at Plot - 3, Sector - 18A, Dwarka , New Delhi – 110 075, India (Party 1). IIHMR was established to meet the country's needs for a trained capacity in health and hospital management, public health research and practice. IIHMR Delhi strives to build a national and international collaborative campus for research, training and academics.

This Memorandum of Understanding (MoU) is being drawn between International Institute of Health Management Research, Delhi, Plot No 3, Sector 18A, Dwarka, New Delhi – 110075, hereafter referred as IIHMR, Delhi (Party 1) and IIHMR University 1, Prabhu Dayal Marg, Sanganer Airport Jaipur- 302011 (Party 2).

Activities:

The precise nature of the activities will be defined through mutual agreement from time to time and depending on specific circumstances of the case.

The principal activities of the proposed MoU would be that the two parties would jointly participate in activities of mutual interest and need for benefit of both the parties and will consist of (not limited to):

1. Academic activities
2. Research and evaluations
3. Training programs

Timeframe and Cancellation:

The parties agree to have the MoU in force for a period of three years beginning 1 July 2021 to 30 June 2024. Extension of this period may be done upon satisfactory completion subject to approvals from both parties at that time.

Either part reserves the right to terminate this MoU with or without cause with a notice of three (3) months in writing.

Financial implications:

The parties agree that any financial arrangements either internal (party 1 or party 2 or both) or external will be negotiated in writing as and when the activities are proposed and funded.

Other clauses:

1. Before initiating any joint program, there would be separate written contract on deliverables, timeline and financial implications involved in that particular endeavour.
2. In the case that any specific program or activity results in or impacts upon matters of intellectual property rights arising there from, the *parties* will discuss in good faith and agree in the separate document the conditions regarding the treatment of intellectual property rights so arising, prior to the start of the specific program or activity
3. The *parties* agree that this MoU is not a formal legal agreement giving rise to any legal relationship, rights, duties or consequences, but it is only an expression of mutual interest in academic and research collaboration. Therefore, nothing in this MoU is intended to be legally binding on any of the parties
4. Neither *party* will use the name or marks of the other in any press materials or web-based or other publication without the prior written permission of the other *party*; provided that each *party* may include the name of the other on any routinely-maintained published list of institutional collaborations during the term of this MOU.

Annexure 1

IIHMR Delhi received a request from NHM Odisha to conduct courses on Executive MPH and PG Dip in Public Health Financial Management for program managers. Following that IIHMR Delhi initiated discussions with IIHMR University to assess the suitability of IIHMR for courses as per the mandate of IIHMR. Formal discussions were held with NHM Odisha to decide on the course structure and fees.
