

Introduction

The University

The IIHMR University has been established and incorporated as a postgraduate research University by Government of Rajasthan vide the IIHMR University Ordinance, 2013 (Ordinance No. 30 of 2013) promulgated on September 27, 2013 by the Governor which was replaced by the IIHMR University Act, 2014 (Act No. 3 of 2014) passed by the State Legislature on February 07, 2014. The Act of 2014 received the assent of the Governor on 25thday of February 2014 and was notified in Rajasthan Gazette Extraordinary on February 26, 2014. It has deemed to have come into force on and from September 27, 2013.

Origin

The genesis of the IIHMR University dates back to October 5, 1984, when its sponsoring body, the Indian Institute of Health Management Research (IIHMR)was established and registered as a non-profit Society under the Rajasthan Societies Registration Act, 1958. The Institute was established with a mission of improvement in standards of health through improved management of health care and related programmes through management research, education, training, consultation and institutional networking in a national and global perspective. IIHMR successfully created and established a new discipline of health management in the country and over the last 35 years, IIHMR has established itself as a unique research, education and training organization in India and South-East Asian Region. After pursued the cause of management research, academics and capacity building exclusively in the health sector for about three decades, the institute submitted a proposal before the State Government as per the guidelines for establishment of private universities by separate Act. The proposal of the university was accepted by the government.

Objectives

As defined in Section 4 of the IIHMR University Act, 2014, the objectives of the University shall be to undertake only postgraduate education and research in the disciplines specified in Schedule II and such other disciplines as the University may with prior approval of the State Government, determine from time to time and to achieve excellence and impart and disseminate knowledge in the said disciplines. The mandated disciplines which have been mentioned in Schedule II of the Act are as under:

- Public Health
- Health and Hospital Management
- Population and Reproductive Health
- Nursing Management
- Pharmaceutical Management
- Rural Management

- Health Economics and Finance
- Urban Health
- Nutrition and Health

- NGO Management and Entrepreneurship

Endowment Fund

The endowment fund was created by the sponsoring body of the IIHMR University by depositing Rs. Two Crores in the Public Deposit (PD) Account with the State Government of Rajasthan on September 11, 2013 under Section 8 of the IIHMR University, Jaipur Act. This endowment fund shall be used as a security deposit to ensure that the University complies and functions with the Act's provisions. The income from the Endowment Fund may be utilized for the development of the infrastructure of the University.

Collaborations

The University has been instrumental in setting up collaborations and networking globally with various national and international organizations to promote postgraduate education, research and capacity building in the mandated disciplines. The University takes pride in having of collaborative partnership with the following prestigious institutions and organizations:



Johns Hopkins University, Bloomberg School of Public Health, and IIHMR University signed a Memorandum of Understanding in the area of research, education, and training. The idea behind was to provide a focus on public health capacity building in developing countries; cultivating students health management skills thereby enhancing the effectiveness and efficiency of public health programs and services; and preparing professionals for exciting careers in public health management in the public and private sectors, non-governmental organizations (NGOs) and national and multinational organizations.



IIHMR University and the University of Chester, U.K. have signed Memorandum of Understanding (MOU) to enhance academic and research opportunities for the staff and students and also to develop cultural linkages between both the Universities in the field of public health. The MoU aims to develop quality and enhance the learning and teaching, improve learning environments and opportunities for students, develop and share publication and other materials of common interest, identify

trans-cultural similarities and differences, develop collaborative external funding proposals, deliver dual, joint or common programmes, such as seminars and conferences. The collaboration came into existence from January 31, 2017 for three years.

Curtin University

The Curtin University, Perth, Australia entered into a Memorandum of Understanding with IIHMR University on August 31, 2016 for a period of five years. The MoU focusses on developments in learning and teaching quality, improving learning environments and opportunities for students, developing and sharing publications of common interest, organizing seminars and conferences, research collaborations and student exchange.

Université **m** de Montréal The IIHMR University and The Université de Montréal, Montreal, Canada, have entered a MoU on September 21, 2016, for a period of 5 years. The agreement of cooperation, inter alia, includes exchange of faculty members, research scholars and students at all levels, joint research projects and joint mentoring programs, organizing workshops, symposiums and conferences.



The IIHMR University signed a cooperative agreement with Khesar Gyalpo University of Medical Sciences, Bhutan on November 11, 2016 for a period of 5 years. The agreement was to specifically focus on exchange of faculty and staff; exchange of students and publications; academic materials and information on joint research activities and scholarship programs; develop and conduct joint academic programs, research grants; human resource development; developing collaborative external funding proposals; and other developmental activities directed towards strengthening health systems in Bhutan including academic programs.



South-East Asia Public Health Education Institution Network (SEAPHEIN) has been created by the WHO South-East Asia Regional Office to promote collaboration and sharing of information and knowledge among the member countries in the Region in pursuit of strengthening public health education and training. IIHMR University is a founding partner of the network and has signed agreements for collaboration with various institutions in SEAR countries to promote capacity building in public health, management and joint collaborative research.



To promote public health education in India, India Public Health Education Institution Network (IndiaPHEIN) has been developed and promoted under the stewardship of WHO-SEARO. The University hosts the Secretariat of IndiaPHEIN and plays a leading role in establishing the network to strengthen public health education in India.



The IIHMR University has been collaborating with Bharat Rural Livelihoods Foundation (BRLF), an autonomous body of MoRD, GoI since 2017. The central themes of the cooperation are to create multi-location multi-thematic multi-partnered academic programs for scheduled tribes, de-notified tribes, nomadic tribes, and other marginal social groups, with a special focus on youth and women, with the aim to develop them as rural livelihood professionals.



The IIHMR University, Jaipur, India andKandahar University, Kandahar, Islamic Republic of Afghanistan, have entered into a collaboration to establish a formal understanding of cooperation and friendship intended to enhance academic objectives further and promote better understanding between the faculty and students of IIHRMU and KDRU. The areas of cooperation include exchange of faculty members, exchange of students, joint research activities, participation in seminars and academic meetings, exchange of academic materials and other information, conduct short and long-term academic programmes, and pursue efforts to generate funds for the mentioned activities. The collaboration came into existence from December 18, 2018 for five years.



The IIHMR University and Malviya National Institute of Technology (MNIT) entered into a collaboration in the areas of Teaching, Research, and Training in the domains of public health, health and hospital administration, pharmaceutical management and rural development. The collaboration came into effect from February 08, 2019 for five years. This venture will especially focus on Student and faculty exchange, partnering and supporting each other through joint research initiatives/projects, offering joint courses/programs in areas of common interest, and other academic/professional activities such as organizing conferences/seminars.



The IIHMR University in collaboration with Amrit Yoga Institute signed MoU on Capacity Building, exchange programs, conducting workshops and joint research workshops in the area of Healthcare, Yoga, Wellness and related areas on January 29, 2020 for two years.



The IIHMR University signed an MoU with Commonwealth Infrastructure Partners Ltd. U.K. for furthering collaborations and development activities in the UK-India Context. The MoU will reinforce the 'aspects of cooperation' towards impinging 'Knowledge Management-Innovation-Institutional Development' measures by undertaking collaborative initiatives. The areas of cooperation include student exchange, international students in-take for the Graduate MBA Programs at IIHMR University, Design, Develop and Deliver on a techno-commercial mode, immersion programs/mid-career executive education programs for the administrators andbusiness groupson thematic areas such as (a) Public Policy and Governance, (b) Health Care Management and (c) Public - Private Partnerships. The MoU aims to leverage 'Institutional Capacity Building Initiatives' for PSUs and Quasi Government Organizations in the Indian Region, to 'Design, Develop and Execute, one Summer

School/Winter School' during May and December every year for graduate students of IIHMR University in the UK with (a) University of Sussex, (b) London-South Bank University and (c) University College London. The MoU came into existence from February 07, 2020 to February 02, 2025 for five years.



The IIHMR University, Jaipur, India and B.N Patel Institute of Paramedical and Science, Anand (Gujrat) have entered into a MoU to establish a formal understanding of cooperation and friendship intended to conduct joint research in the areas of mutual interest, provide the manpower needed in the research and development, organize meetings, trainings and workshops, provide consultancy services in the areas of mutual interest and organize certificate courses in scientific and social science temper and research technologies. The areas of cooperation include exchange of staff and students in the areas of mutual interest, possible ways to develop research culture for the students in the institution and the scope of academic and outreach activities. The MoU came into existence from March 03, 2020 to March 02, 2023 for three years.



The IIHMR University, Jaipur, India and Access Health International signed a MoU to establish terms and conditions for undertaking capacity building for enabling digital health future by conducting educational, training, mentoring, and skill development programs for students, working executives and other human workforce dealing with healthcare, provide consultation to design innovative solutions and drive digital transformations for 3 Ps (Payers, Providers and Patients) of the health care ecosystem, conduct research to provide actionable insights through rigorous and actionable analysis, contributing to Universal Health Coverage and Sustainable development goals and to facilitate better interaction between the Incubation Centre of Access Health and Centre for Innovation, Incubation and Entrepreneurship (CIIE). The MoU came into existence from December 09, 2019 to October 31, 2021 for two years.



The IIHMR University, Jaipur, India and Save the Children (Bal Raksha Bharat) signed a MoU to engage IIHMR University faculties as expert member in the TAG, develop SBCC strategy and health facility assessments, TAG Secretariat of Project Vishwas for Holding quarterly review meetings, promote IIHMR University logo/ brand for all joint events/meetings under this MoU, provide exposures to IIHMR University students in intervention areas. The MoU came into existence from October 01, 2019 to September 09, 2021 for two years.



The IIHMR University, Jaipur and Lords Education and Health Society (LEHS), New Delhi signed a MoU to conduct research activities and projects by the scientific personnel of the parties and seek mutual advice and support in planning and executing programs, promoting excellence in primary healthcare research, improve the primary healthcare system, planning, and policymaking through evidence-based documentation/health technology assessments/ third party validation of

findings, development of guideline, capacity building, and advocacy at different levels, support research designs/tools for various studies vis-à-vis utilization of existing institutional/ethical review committee/board for initiating studies in the field, organize conferences/symposia of national and international importance in primary healthcare/digital health/innovations for primary health care and like, explore strategic partnerships with the potential development partners, donors and other stakeholder institutions for developing and implementing joint projects/ programs. The MoU came into existence from July 22, 2019 to July 21, 2022 for three years.

Governance

The University is governed under the provisions of the IIHMR University, Jaipur Act, 2014, the Statutes made thereunder and the University Grants Commission Act, 1956.

The Sponsoring Body

The Indian Institute of Health Management Research (IIHMR), Jaipur as sponsoring body took the initiative to establish IIHMR University. The sponsoring body manages the University through appointing the chairperson and nominating persons in the Board of Management. Meetings of the Board of Management

During the Year 2019-20, the meetings of the Board were held in accordance with the provisions of the Act and Statutes made thereunder. The sixteenth meeting of the Board was held on June 07, 2019 and the seventeenth meeting of the Board was held on January 04, 2020. The minutes of the meetings were shared with the Board members.

The Statutes

The statutes were prepared by the University and the Board of Management approved them in its second meeting dated July 28, 2014. The statutes were sent to the State Government for approval on July 31, 2014. The Joint Secretary, Higher Education Department, requested the University on September 03, 2014 to modify the statutes as per the corrections made at appropriate places. The University modified the statutes and submitted before the Joint Secretary on September 11, 2014. Thereafter, the Joint Secretary again raised some queries on June 15, 2015, October 16, 2015 and December 08, 2015 respectively. All the relevant queries were replied instantly but still the statutes are under consideration with the State Government.

The Academic Council

The Academic Council is the principal academic body of the University and subject to the provisions of the Act and the Statutes, Regulations and Ordinances. It co-ordinates and exercises general supervision over the University's academic policies.

The first Academic Council was constituted on December 07, 2013 for two years and the reconstitution of the council was done on February 15, 2016 for the next two years, then the reconstitution of the council was done on February 06, 2019 for the next two years. Core Activities

Research

IIHMR University is primarily a Research University. It has enabling ambiance and adequate infrastructure for conducting high-quality research. The University has created conductive conditions to enquire into the burning research questions with transparency, trust, accountability, and autonomy. A sincere effort is made to build the capacity of the faculty and research staff in planning, designing, and conducting research workshops, training, seminars, and conferences. Every year, the University earmarks budget for in-house research grants to promote research activities in the University. The research activities are given due credit in the Key Result Areas of the faculty members on their annual performance appraisal. Most of the faculty members are actively involved in the processes of the research activity at some of the other stages of the research project-proposal submission, implementation, data analysis, report writing, and taking feedback.

Research and Consulting

The University has worked for various agencies that fund research in the area of health, hospital, nutrition, water, and sanitation. The IIHMR University submitted 27 research proposals in the year 2019-20. The clients were UNFPA, ICMR, UNICEF, Tata Trusts and State Institute of Health and Family Welfare, Rajasthan. The awarded research projects in 2019-20 were in the fields of universal health coverage, nutrition and food fortification.

During the year 2019-20, the University completed six research projects, including one consultancy project. There is one research projects which is ongoing in the next financial year. The information on completed and ongoing research projects is summarized in Table 1.

Integrated Road Traffic Injuries Surveillance (IRIS) - INDIA

The IRIS – India was initiated with a broad objective to establish an electronic-based comprehensive and integrated road traffic injuries (RTI) surveillance system, to assess the burden of RTI, its risk factors, and outcomes across rural and urban settings of major cities in India. This study was conducted in two metro (Chennai and Delhi) and three other major cities (Chittor, Dehradun, and Jaipur) located across the country. In Jaipur center, SMS Hospital, Barala Hospital (Chomu), and two sub-centres (Sirasali and Jaitpura) were included.

Objective(s) of the project:

- 1. To design an online electronic-based RTI surveillance system (mobile app) that enables the capture of RTI data from various sources.
- 2. To conduct a situation analysis of data sources, systems, and quality for RTIs.
- 3. To assess the facilities available for pre-hospital and trauma care in the district including for emergency transport system (e.g. EMRI 108) and their utilization.
- 4. To describe the availability and utilization pattern of existing facilities for post-crash and emergency care at various levels of the health system in both urban and rural areas.
- 5. To describe the burden of road traffic accidents and its epidemiological factors including the outcome.
- 6. To describe factors associated with RTI of serious nature.

Supporting National Health Mission (NHM) in Developing Capacities of Health care Staff on the Improvement of WASH in Health Centers and NRCs in Selected Districts and further Scale up Across the State in Madhya Pradesh

Agency: United Nations Children's Fund (UNICEF), Madhya Pradesh

UNICEF, Madhya Pradesh (MP) in partnership with National Health Mission (NHM), MP aims to build the capacity of the state and district level officials for improvement of Water, Sanitation and Hygiene (WASH) in

Health Centers and Nutritional Rehabilitation Centre (NRC) in selected districts of Madhya Pradesh. IIHMR University, Jaipur implemented the program in nine high priority districts (HPDs) named Anuppur, Umaria, Shahdol, Mandla, Guna, Sheopur and Shivpuri, Alrajpur and Jhabua with the following aim:

- Build capacity of Healthcare staff, consultants, and mentors on WASH-related issues, especially demonstration of safe WASH practices and use of monitoring tools, including support implementation of WASH improvement plans.
- 2. Assess the status of WASH infrastructure, services, and systems in the selected facilities.
- Develop facility wise phased WASH improvement plans by the agency team, mentor team, BMOs, and the MoICs
- 4. Handholding support to MolCs/Health staff in the operationalization and monitoring of the WASH improvement plans.
- Share findings of assessment and operationalization of improvement plans with NHM implementers
 and policymakers for improved action and resourcing for WASH in health and contribute to state
 strategy and statement of procedures (SOPs).

During prescribe period July 2016-August 2019 around 200 health professionals including Deputy Director (Quality Assurance), State Consultants from NHM, Chief Health and Medical officer (HMOs), DPMs, Medical Officers of facilities, In-charge Medical officers of NRCs, DCM, Program officers were trained on the aspect of WASH and how to bring changes by involving themselves in assessment and developing improvement program. The changes were measured by Star grading tools, which revealed that around 76 percent of the facilities were achieved more than 75 percent on WASH compliances, and around half of the facilities comply up-to 90 percent of the WASH parameters. This was possible by building the capacity of around 700 staff nurses and cleaning staff in 19 sessions across 7 districts. Not only this, but the divisional level workshop was also organized to ensure impact in the health facilities of the 32 ODF block spread across another 11 districts. Key findings were shared with the Mission Director and other stakeholders to bring attention to making a separate policy on WASH for health facilities and leveraged around 78 lakhs from an untied fund for making the significant and sustainable change.

Assessment to Understand Social Determinants around Vaccine Hesitancy and Acceptance

Covering an area of 3,42,239 sq. km. (1,32,150 sq. miles) Rajasthan is the largest state in the Republic of India. The growth rate of the population in the state at 28.41 % was higher than that of the country 21.34 %. The state is thriving towards attaining the desired results on health indices especially the maternal and child health and making a concerted effort in improving the quality and access of maternal, newborn, and childcare as well as vaccination. Various study indicates a remarkable reduction in child mortality in countries with poorest child survival indicators following the introduction of immunization against vaccine-preventable diseases. In Rajasthan, the most recent NFHS-4 indicates that more than half (55%) of children aged 12-23 months received all essential vaccinations against six major childhood illnesses (tuberculosis, diphtheria, pertussis, tetanus, polio, and measles) at any time before the survey. However,

most children are at least partially vaccinated. 65% have received at least the recommended three doses of the polio vaccine, 72% have received the three recommended doses of DPT vaccine, and 78% have been vaccinated against measles. Eighty-nine percent of children have received a BCG vaccination. Though it is vital to prevent the morbidity and mortality associated with vaccine-preventable diseases and their complications, yet in the state of Rajasthan, 7% of the children have not received any vaccinations. Far fewer children have received other basic vaccinations. In the state of Rajasthan in some of the districts (around 5-6 districts) the dropout and hesitancy in continuing the vaccination was noticed. There is a considerable dropout between the first and third doses of DPT vaccine (from 86% to 72%) and the polio vaccine (from 88% to 65%). Between NFHS-3 and NFHS-4, there was significant increase in the vaccination coverage for three doses of DPT (from 39% to 72%), measles (from 43% to 78%), and BCG (from 69% to 89%); however, coverage for three doses of polio vaccine has remained unchanged at 65 percent during this period. Further, the disparity is also evident among the coverage with all necessary vaccinations, where it is higher in urban areas than in rural areas (61% versus 53%) and is high for children whose mothers have 12 or more years of schooling, for first births and female children. Muslim children have lower vaccination coverage than Hindu children and scheduled tribe children to have lower vaccination coverage than children from other castes/tribe groups. Hence to optimize control of vaccinepreventable diseases in communities, high uptake rates of vaccines must be achieved. Therefore, there is a great need to understand individual and community hesitation and reluctance towards vaccination.

Objective(s) of the project:

- To assess the degree of vaccine hesitancy in acceptors and non-acceptors for specific vaccines administered under the Universal Immunization Programme in selected districts of Rajasthan.
- To assess the salient factors influencing vaccine hesitancy for specific vaccines administered under the Universal Immunization Programme in selected districts of Rajasthan.

Rice Fortification Pilot in Gadchirolli in Maharashtra

Agency: Sir Dorabji Tata Trust, Mumbai

Tata Trusts propose to demonstrate a reduction in anemia and other micronutrient deficiencies in all the blocks of Gadchirolli district through a rigorous impact evaluation of an intervention aimed at providing micronutrient fortified rice through the public distribution system (PDS) of Maharashtra.

Objective(s) of the project:

- 1. To understand the effect of fortified rice supplied through Public Distribution System (PDS)
- 2. To assess the change in the hemoglobin level of consumers receiving fortified rice and understand the attributable change due to fortified rice
- 3. To understand the operational feasibility of the program
- To identify the gaps or barrier in implementing the Rice Fortification Project.

System Strengthening for Evidence-based Planning and Review through Capacity Building of the Officials on the Use of Data

Agency: United Nations Population Fund (UNFPA), Rajasthan **Team**: Dr. Anoop Khanna, Dr. J. P. Singh, Mr. V. B. Tripathi

Rajasthan is one of the pioneer states which took an early lead in the facility reporting of HMIS and designing and implementing PCTS (Pregnancy and Child Tracking System). PCTS is an online software used as an effective planning and management tool by Medical, Health and Family Welfare Department, Govt. of Rajasthan. The system maintains online data of more than 13000 government health institutions in the state. Besides HMIS and PCTS, there is other information system software, like – 'Asha Soft' to capture beneficiary wise details of services given by ASHA to the community, 'e-Aushadhi' to deals with the stock of various drugs, sutures, and surgical items required by different district drug warehouses, 'e-Sadhan' for family planning logistics management, etc. Ahuge amount of information is collected and managed through such information sources, that can be used for program planning, management, and monitoring at different levels. However, the use of information is not optimal and has been a major problem in the health system in Rajasthan. It is felt that there is currently a lack of capacity among supervisors for analysis and appropriate use of data for monitoring progress and for taking corrective actions locally. Because of this limited capacity, data is transmitted without proper understanding or analysis to higher reporting levels. It is realized that there is a need for improving the skills of supervisors at all levels for appropriate use of data, received from lower levels, at their level so that feedback could be provided to them and corrective action can be taken accordingly. In order to strengthen the health system in evidence-based decision-making at different levels, UNFPA in collaboration with IIHMR University initiated a project to build capacities of the state, district, and block-level health officials and data managers in Rajasthan on use of data.

Objectives of the project:

- To build the capacities of health officials and data managers on the use of data for planning and monitoring.
- To establish a mechanism to promote and sustain evidence-based planning and monitoring.

Admission Procedure

The University has a comprehensive admission policy duly approved by the Academic Council and the Board of Management. The selection of students is based on past academic performance, MAT or equivalent scores, experience, Group Discussion and Personal Interview. An appropriate weightage is given to each element. The admission process of the University is transparent, which is solely based on equity and merit. The results are declared immediately after the Group Discussion and Personal Interview is over.

The University adheres to the State Government's policy on reservations for the students belonging to SC, ST, OBC, differently abled and women categories.

Eligibility Criteria

MBA Hospital and Health Management

Recognized bachelor's degree of minimum 3 years duration with at least 50% marks (45% for SC, ST and OBC candidates) in aggregate in any discipline (Medicine/ Pharmacy/ Biotechnology/ Science/ Management) with valid score of management aptitude tests. Candidates with relevant experience in the healthcare sector are encouraged to apply.

MBA Pharmaceutical Management

Recognized bachelor's degree of minimum 3 Years duration with at least 50% marks (45% for SC, ST and OBC candidates) in aggregate in any discipline (Medicine/ Pharmacy/ Biotechnology/ Science/ Management) with valid score of management aptitude tests. Candidates with relevant experience in the pharmaceutical sector are encouraged to apply.

MBA Rural Management

Recognized bachelor's degree of minimum 3 Years duration with at least 50% (45% for SC, ST and OBC candidates) marks in aggregate in any discipline (Medicine/ Pharmacy/ Biotechnology/ Science/ Management) with valid score of management aptitude tests. Candidates with relevant experience in the rural management/development sector are encouraged to apply.

PhD

Recognized masters' degree or Post-Graduate Diploma in Management (PGDM) from a UGC/ AICTE recognized institution or University, with at least 55% marks (50% marks for SC/ST/OBC candidates) or equivalent grade in hospital and health management, general management, medicine, nursing, pharmacy, health informatics, social and behavioral sciences, economics, commerce, science, demography and statistics. Faculty and working professionals with relevant qualifications and experience are encouraged to join the programme. IIHMR University encourages working professionals (health administrators, policy makers, and medical/ nursing/ pharmaceutical/ development sectors/ management professionals) to undertake the Ph.D. Programme to enhance competence in evidence-based research for policy and programme development.

Master of Public Health

Should have a bachelor's degree; A minimum of two years of full-time health-related experience beyond the bachelor's/ master's degree (work experience is waived for Ph.D. and M.B.B.S.); Prior college-level mathematics courses; prior college-level biology course plus another health-related course; Demonstrated English proficiency through prior degree, TOEFL or IELTS, Demonstrated quantitative and verbal skill through GRE, MCAT, LSAT or GMAT. (Applicants with degrees beyond the bachelor's degree may request a waiver of standardized test scores if they are other sources of quantitative abilities.)

Diversity

The University greatly values diversity in all the academic programmes. The table given above manifestly depicts that 64.5% of the students are females and they represent various states of the country. They also come from diverse academic backgrounds like Medicine, Dentistry, Science and Technology, AYUSH, Arts, Nursing, Biotechnology, Pharmacy, Management, Commerce etc. The Master of Public Health programme which is offered in academic collaboration with Johns Hopkins University, Baltimore, USA, is offered to candidates from South-East Asian countries.

Academic Session Plan

The Academic Plan of the University is prepared by the Dean, Academic and Student Affairs in consultation with other Deans and faculty members. The student feedback is also considered while finalizing the session plan. The academic plan is submitted to the Academic Council of the University for approval before the commencement of the academic session. After obtaining approval from the Academic Council, the plan is shared with faculty members and students. The plan is also displayed on the University website.

TRAINING

The IIHMR University, Jaipur is a leading University in the country for skill development to improve the management practices in the health sector. The training and capacity building efforts of the university benefited huge number of policymakers, advisors, hospital managers, health managers, planners, decision-makers, and pharmaceutical professionals at national and international levels to improve the leadership and management skills.

From April 2019 to March 2020, it has conducted 26 programs, including 11 MDPs, 12 CTPs, 2 workshops and 01 conference. In all, 466 participants attended these programs. The participants were from the following 18 countries: Afghanistan, Bangladesh, Bhutan, Gambia, India, Japan, Kenya, Liberia, Lebanon, Lagos, Nepal, Myanmar, Uganda, Nigeria, Maldives, Tongo, Papua New Guinea, Sri Lanka. The Indian participants were from 12 states: Assam, Maharashtra, Madhya Pradesh, Chhattisgarh Haryana, Delhi, Tamil Nadu, Karnataka, Rajasthan, Uttar Pradesh, Uttarakhand and Himachal Pradesh.

Management Development Programs (MDPs)

IHMR - Management Development Programs

- 1. Healthcare Operations Management: Techniques and Applications, May 31 June 2, 2019: The objectives of the program were to make hospital and health managers evaluate hospital projects with PERT/CPM techniques, to understand forecasting techniques in health care operations, understand the inventory control techniques, understand the quality management and quality control techniques in hospitals, to queuing model formulations in hospital services. In all there were seven participants. The program was coordinated by Dr. Susmit Jain.
- 2. Public Health Analytics and Data Visualization, August 28-30, 2019: The major objectives were to learn practical tools and approaches for visualization for better decision-making and understanding of information. The program was attended by seven participants. The program was coordinated by Dr. Shweta Agarwal.
- 3. Leadership and Strategic Management in Healthcare for Senior Management Executives, September 23-26, 2019 in Goa: The objectives of the program were to strengthen leadership and

managerial competencies of senior management professionals. It was designed to transform senior management executives into high performing leaders who can capitalize on existing opportunities and organizational strength for improved management. In all, there were 15 participants from four counties, namely Afghanistan, India, Nepal and the Maldives. The Indian participants were from four States, namely Andhra Pradesh, Chhattisgarh, Madhya Pradesh, Uttar Pradesh. The participants were from governmental and non-governmental organizations. The program was coordinated by Dr. P. R. Sodani.

4. Lean Six Sigma in Health Care, November 15-17, 2019: The objectives of the program were to train the healthcare managers in using Lean Six Sigma tools and techniques in the efficient and effective management of healthcare services. Six professionals from India attended the program. The participants were from Government, and Non-Governmental agencies. The program was coordinated by Dr. Susmit Jain.

IHMR - Custom Training Programs

- 1. Inner Development for Outer Transformation for Senior Executives, April 11-13, 2019: The Power Grid Corporation of India Limited, a Government of India Navratna PSU under Ministry of Power, Government of India requested the IIHMR University, Jaipur to design and organize a three-day training program on "Inner Development for Outer Transformation for Senior Executives. The objectives of the program were to understand the scientific mechanics and the physiology of respiration, better knowledge of basic breathing methods, able to use pranayama as a therapy, describe and demonstrate at least three techniques to heal body and mind. The program was coordinated by Dr. P. R. Sodani.
- 2. Hospital Preparedness for Health Emergencies for Senior Hospital Administrators, June 10-15, 2019: The program was conducted for senior hospital administrators such as medical superintendents and deputy medical superintendents. In all, 30 participants from the Government of Rajasthan, Government of Madhya Pradesh and Government of Gujarat participated in the program. The program was coordinated by Dr. Sandesh Kumar Sharma.
- 3. Hospital Preparedness for Health Emergencies for District Health Officer, July 15-27, 2019: The program was conducted for district health officers of Rajasthan. The program was attended by 18 district health officers such as medical officers, health managers and junior surgeons. The program was coordinated by Dr. Sandesh Kumar Sharma.
- 4. The University follows the service conditions as laid down by the UGC. The University advertises the vacant positions in national dailies as well as notifying the vacancies on employment related websites. A selection board, duly headed by the President, constituted by the Chairman of the University conducts interviews and selects the appropriate person for the vacant slot. The process of recruitment is transparent and independent.

The prominent features of the center are newest servers, latest computers, laptops, laser printers, video conference facility, interactive classrooms, LCD Projectors, online UPS, email server, technically competent software and hardware professionals. The center is having cloud-based campus agreement with Microsoft which allows using different Microsoft packages for academics. Apart from this center is also having statistical packages (SPSS, STATA, ATLAS. Ti), ARC GIS, Microsoft office, Antivirus software. The center is also having perpetual software licenses and dedicated hardware for managing e-learning courses.

The center has fiber optic based wired and Wi-Fi based wireless local area network connecting nodes throughout the campus. Centre is also outfitted with windows server and other servers for better communication and interconnection at internal and external level.

Fast speed internet access is available with the help of dedicated (1:1) Lease line. Internet facility is made available to the staff, student and training participants for external communication and for global exposure to research and training. Use of internet is closely monitored by a powerful Unified Threat Management appliance fulfilling the norms of Ministry of Communication and IT (DoT, GoI).

IIHMR University has implemented ERP in all its internal processes by collaborating with Serosoft. A competent team of individuals from the IT Department, with the help of other major departments in the university, has successfully implemented the ERP in several phases. The ERP is a user friendly and handy system that has been carried out to ensure automation and online functioning.

A well-qualified team is enthusiastically mixed up in developing and managing internal, external software package and research tools. The research tools are developed using specific technologies for effective use of computers science in the domain of Public Health.

The centre acts as a central nervous system ensuring efficient digital operations and bringing life to every activity of the University.

Dr. D. A. Henderson Library and Documentation Centre

The IIHMR University Library and Documentation Centre was dedicated on May 31, 1996 to Dr. D. A. Henderson, renowned for his outstanding contribution to eradicating smallpox.

The University's Library is housed in a centrally located main University building spread across 292.314sq. mtr. (approximately). Spacious reading halls and the latest IT infrastructure provide the right environment for reading and research in the Library. The library is developing a comprehensive collection of print, digital and media resources on Public Health, Health Systems, Health and Hospital, Pharmaceutical Management, and Development Studies, to fulfill the teaching and research needs of the three schools of the University. The library's objective is to provide appropriate and adequate material in a minimum amount of time enabling them to achieve excellence in research, teaching, learning, and community services.

It is to be noted that this is the first automated library in the state. It is divided into three functional units viz., Technical Unit, Documentation Unit and Information Unit. The staff maintains the records through KOHA (version: 18.11.04.000). The library has a Wi-Fi facility, circulation, web OPAC, and a digital repository available through Greenstone software. The IIHMR University Library also provides RemoteXs facility to current students and faculty.

Publication

Library publishes abstracts of the dissertation submitted by the MBA students. The IIHMR University Library and Documentation Centre, Jaipur, is annually bringing out a publication "Abstracts of Dissertations" since 2010. It is a continued, systematic, and sincere effort to Collect and collate abstracts of students' dissertations.

Library Resources

The University library collection is mainly focused on Health Management, Hospital Administration, Health Economics and Finance, Public Health, General Management, Management Information Systems, Population, Research Methodology, Sociology, Economics, Rural Management, Pharmaceutical Management and Computer Science. - Demand of money in excess of that specified in the declared admission policy or approved by the competent authority to be charged by such institution.
- Breach of the policy for reservation in admission as may be applicable.
- Complaints of alleged discrimination by students from Scheduled Caste, Scheduled Tribes, OBC, women, minority or disabled categories.
- Non-payment or delay in payment of scholarships to any students that such institution is committed.
- Delay in conduct of examinations or declaration of results beyond that specified in the academic calendar.
- On provision of student amenities as may have been promised or required to be provided by the institution.
- Denial of quality education as promised at the time of admission or required to be provided.
- Non-transparent or unfair evaluation practices.
- Harassment and victimization of students including sexual harassment.
- Refund of fees on withdrawal of admissions as per university norms.

Industry Academia Interaction Cell

Centres of Excellence

IIHMR University has been engaged in policy issues, planning and management, research and capacity building, mainly in the health sector for over three decades. It has defined health management education and has substantially contributed to research and training. Its education, research and training programsfocused more on health and hospital management, population and reproductive health and evaluation, health economics and finance, human resource, pharmaceutical management, rural management and primary health care. In light of its rich experience in health sector, and the felt need for commencing focused studies on various thrust areas, the IIHMR University has established dedicated Centers at the University.

Centre for Injury Research (CIR)

Globally, Injuries are emerging as one of the leading causes of loss of lives and physical infirmities constituting over 20 percent of human deaths and disabilities occurring each year. In India Injuries are responsible for about 12% of deaths and disabilities in a year. Rapid economic development resulting in urbanization, industrialization, and climate change significantly led to a steep rise in injuries caused by accidents, natural calamities, communal and familial violence. In the early years, the term "Injury" was synonymouswith injury from vehicular accidents, but now the scope of injury is wholly inclusive. It is being considered as an essential public health issue to be addressed on priority.

India has registered an alarming increase in hospitalization of injury inflicted patients. As the occurrences of sustained injuries to human lives are sudden, random, and uncontrollable, there has been less attention to evaluating the causes, intensity, magnitude, and consequences of injuries. This has been noticed that scientific knowledge and analysis possibly help a great deal in permeating awareness about the potential injuries which can prevent and control the injury occurrences. If systematic research is conducted on various aspects and nature of injuries, appropriate remedial measures can be taken well in time. Keeping this fact in mind, a Centre for Injury Research (CIR) has been established in IIHMR University in collaboration with Johns Hopkins International Injury Research Unit at Bloomberg School of Public Health, JHU, and Baltimore, USA, with the mandate to:

- Redefine injury as an urgent public health issue and to promote it as a scientific discipline through quality research, education, and advocacy
- Conduct studies and implement projects relating to injuries, identification, understanding, patterns, risk factors, prevention opportunities, treatment options etc.
- Collaborate with the governments, non-governmental and business organizations, and stakeholders to document the incidence and impact of injury, understand its causes, identify effective interventions, and promotedisseminating of information and policies.
- Build capacity of researchers, health professionals, policymakers, stakeholders, and field officers/ staff involved in injury control and prevention.

- Influence Government policies, systems and legislation for effective prevention and control of injuries through evidence-based research and dissemination of information.
- Spread awareness and facilitate dialogue among public health practitioners, policymakers, researchers, and the general public about the importance of injury prevention and research.

The Center is striving to bring synergy and convergence through coordination in various disciplines, organizations and arms of the Government like epidemiology and biostatistics; social and behavioral sciences; law and criminal justice; police and transport; disaster relief, engineering and design; health services research; health and public policy; health education and communication; economics; and nursing and medicine.

Following are the activities being conducted during the year 2018-19:

- 1. Study on Burn Injuries in Rajasthan
- 2. Integrated Road Traffic Injuries Surveillance India Project (IRIS-India)

Training and Capacity Building

A Training session was conducted for the students of MBA (Health, Hospital, Rural and Pharma) of IIHMR University on preparing IEC materials for awareness generation regarding road safety during February 2016. The training was facilitated by Dr. Alok Mathur, Associate Professor, IIHMR University and around 120 students participated in the program. The students were not only sensitized on road safety issues but also acquired skills for developing material on the issue at the community level.

Centre for Health Systems and Policy Research (CHSPR)

The Center for Health Systems and Policy Research (CHSPR) aims to bring together two key domains of 'health policy' and 'health systems' which have hitherto tended to operate in silos. In broad terms, the research carried out at the center seeks to generate new knowledge on how different actors engage and interact in different socio-political milieus to contribute to health policy processes, and how that relates to the public and community health outcomes. The CHSPR is engaged in cutting-edge research and policy advocacy on a wide range of issues about health systems across the South and South-East Asia Region. These include issues such as politics and policies on health financing, health system management and governance, etc.

More specific objectives of the CHSPR are:

- Undertake health policy and systems research in the countries of Southeast Asian Region
- Develop a critical mass of competent researchers in the field of health, hospital, and other related areas
- Generate knowledge and disseminate evidence on effectiveness of health policy and program interventions and components of health systems, and inform the public policies on health

IIHMR University has a long-standing collaboration with the Bloomberg School of Public Health of John Hopkins University, the World Health Organization, and several United Nations agencies. The CHSPR is open to partnership with other leading institutes.

The Centre will collaborate and network with national and international organizations for the advancement of the activities of the Centre.

Centre for Health Economics (CHE)

IIHMRU has been engaged in policy issues, planning and management, research, and capacity building mainly in the health sector for over three decades. It has defined health management research substantially and contributed to research and training and education. The programs are focused more specifically on health and hospital management, population and reproductive health and evaluation, health economics and finance, human resource, pharmaceutical management, rural management, and primary health care. In the light of IIHMR's rich experience in the health sector and felt need for commencing

focused studies on Health Economics, the IIHMR University has established a dedicated Centre for Health Economics (CHE). The mandates of the Centre for Health Economics are:

- To develop and redefine the scope of Health Economics as a new academic program at the University. It will create the necessary expertise, infrastructure, and resources for education, research and training in Health Economics.
- To publish research findings to disseminate the knowledge gained through its activities and influence the policies and fund allocations in health care.
- To provide an excellent platform to design and offer High-Value Training Programs for senior management professionals engaged in policy and implementation of the health care programs.
- To foster dialogue among healthcare economists, health policymakers, health care practitioners, and the public.

Each administrative and academic vertical conducted detailed assessments of the enabling and mitigating factors that are likely to shape the coming financial year's budgetary projections. The result is the proposed budget.

The separate budgeting of the Schools has brought more accountability and awareness about the resource generation at the School level. This exercise will strengthen the self-sustaining character of the University.

1. Method of Accounting

The method of accounting followed by the University is on accrual system of accounting.

- 7. University's educational courses & programmes activities have been approved u/s 10 (23C) (vi) of Income Tax Act, 1961 by Commissioner of Income Tax(Exemptions), Jaipur vide Unique registration number No AAAJI0480N/08/17-18/O-0008/10(23C)(vi) dated 13/08/2018, w.e.f. assessment year 2018-19.
- 8. Overdraft & Bank guarantee limits from HDFC Bank are secured against equitable mortgage of land & Building situated at 1, P.D. Marg, Sanganer, Jaipur, and pledge of fixed deposits and also, pari passu charge on all existing and future movable assets.

9. Contingent Liabilities:

- a. Disputed local taxes amounting to Rs. 90,64,214/-(without penalty) due from 2001 to till date are being contested by the IIHMR and it is hopeful to get the matter settled in its favor. Therefore, no provision has been made in the books of accounts.
- b. IIHMR employee EPF was being deposited with Bhoruka Provident Fund Trust till March 31, 2017. From April 01, 2017, IIHMR University Staff EPF is being deposited in Government administered EPF account. IIHMR has filed an application for grant of exemption u/s 17(1) of the EPF & Misc. Provisions Act, 1952 in year 2009 which is still pending. An inquiry u/s 7-A of the EPF & Misc. Provisions Act, 1952 is initiated against IIHMR & the matter is sub judice. A penalty u/s 7Q & damages u/s 14B of the EPF & Misc. Provisions Act, 1952 may be levied against IIHMR however we are hopeful of settling the matter in our favor. Quantum of liability is unascertainable.

Significant Reportable Activities

Blood Donation Camp

A blood donation camp is conducted as a tribute to the IIHMR's founding inspiration, Shri P.D. Agarwal. Shri P.D. Agarwal memorial Blood Donation Camp was organized on September 17, 2019 in collaboration with Santokba Durlabhji Hospital, Jaipur. One of the main objectives of this blood donation drive was to eliminate blood shortage, especially after the monsoons (September and October), often when seasonal diseases lead to a shortage of blood. A total of 202 doners were registered for the blood donation including, students, faculty, support staff, and BCT staff. During the noble cause, 90 units of blood was collected.

- Staff with travels history to COVID-19 affected places or in contact with such persons are informed to the Director-General of Health Departments to monitor them and allotted to work from home.


- Dr. D. K. Mangal organized awareness programs towards taking precautions to prevent COVID-19 for Faculties and Employees.


Conclusion
