Background

Healthcare delivery in India has undergone rapid transformation with the integration of digital health technologies, telemedicine, artificial intelligence, electronic health records, corporate healthcare systems, and patient-centred care models. Alongside these advancements, healthcare professionals are increasingly exposed to medico-legal scrutiny, consumer litigation, criminal liability, ethical challenges, cyber-security risks, and regulatory compliance obligations.

The growing awareness among patients regarding healthcare rights, combined with evolving legal frameworks such as the Bharatiya Nyaya Sanhita (BNS-2023), Bharatiya Nagarik Suraksha Sanhita (BNSS-2023), Consumer Protection Act-2019, Digital Personal Data Protection Act-2023, Clinical Establishments Act-2010, Telemedicine Practice Guidelines, Biomedical Waste Management Rules, PCPNDT Act, Mental Healthcare Act, and MTP Amendment Act, has significantly increased the legal responsibilities of healthcare providers and institutions.

Medical negligence claims, documentation deficiencies, communication failures, informed consent disputes, cyber breaches of patient data, and violence against healthcare professionals are emerging as major concerns in clinical practice. Hospitals and healthcare institutions are also facing increasing vicarious liability and compliance-related challenges under Indian judiciary and regulatory systems.

This Management Development Program (MDP) is designed to equip healthcare professionals with practical medico-legal knowledge, risk management strategies, ethical decision-making skills, and legally compliant healthcare practices. The program focuses on safeguarding doctors, nurses, hospital administrators, and allied healthcare professionals from negligence claims and litigation risks while strengthening patient safety and quality healthcare delivery.

Through expert lectures, judicial case studies, interactive discussions, and practical demonstrations, participants will develop competencies required for legally safe and ethically sound clinical practice.

- 2 Strengthen medico-legal documentation and informed consent practices
- 3 Enhance understanding of negligence prevention and litigation management

- 6 Train healthcare professionals in legal safeguards during clinical practice
- 7 Improve institutional preparedness for medico-legal challenges and regulatory inspections
- 8 Promote patient safety, risk management, and healthcare quality systems
